

IDX Terms of Use and Linking Agreement

Welcome to this Internet Data Exchange ("IDX") compilation ("Compilation"). This compilation offers online public access to data coming from the most comprehensive and up to date listings of real estate for sale in the State of Utah. These listings are made available by the Wasatch Front Regional Multiple Listing Service, its owner REALTOR® Associations, and the subscribing members of the Wasatch Front Regional MLS ("WFR"). This Compilation is made available subject to the terms and conditions of these IDX Terms of Use and Linking Agreement ("Terms of Use"). These Terms of Use are between you (the user of this Compilation), WFR, and the WFR-licensed IDX provider for the Compilation, iHomefinder, Inc. ("iHomefinder"). Carefully read these Terms of Use before accessing or using the Compilation.

By accessing or using the Compilation, you agree to be legally bound by these Terms of Use. If you do not agree to these Terms of Use, AS THESE TERMS OF USE MAY BE MODIFIED FROM TIME TO TIME, YOU MAY NOT USE THE Compilation, AND YOU MAY NOT create or maintain a link to the website on which the Compilation appears, as set forth in these Terms of Use.
